6. Accidental release measures

Methods and materials for containment and cleaning up Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustibles (wood, paper, oil, etc.) away from spilled material. Ventilate the contaminated area. Minimize dust generation and accumulation. Wear appropriate protective equipment and clothing during clean-up. This product is miscible in water. Stop the flow of material, if this is without risk.

This effect is routinely countered by ensuring sufficient dietary intake of iodine, as perchlorate does not accumulate in the body. Studies on workers in plants where perchlorates are manufactured have shown no thyroid abnormalities; various clinical studies are ongoing. Perchlorates occur naturally in trace amounts in the environment, and are not classified as carcinogenic.
