4. FIRST AID MEASURES

First Aid Procedures:

Inhalation: Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. Call a physician if symptoms occur.

Ingestion: Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, keep head low so that vomit does not enter lungs. Never give anything by mouth to an unconscious person. Call a physician or poison control center if symptoms occur.

Skin Contact: Wash skin with soap and plenty of water for at least 15 minutes. Remove contaminated clothing and shoes. Wash clothing before reuse. Call a physician if symptoms occur.

Eye Contact: Check for and remove contact lenses, if present and easy to do. Immediately flush eyes with gentle but large stream of water for at least 15 minutes, lifting lower and upper eyelids occasionally. Immediate medical attention is required. Call a physician if symptoms occur.

5. FIREFIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions and Protective Equipment: Isolate hazard area and keep unnecessary and unprotected personnel away from the area of the leak or spill. Keep upwind. Wear appropriate personal protective equipment (see Section 8). Avoid contact with eyes, skin, and clothing.

Emergency Procedures: In case of chemical emergency, or if unsure how to address an accidental release, consult a professional (see Section 1).

Methods for Containment: Prevent entry into waterways, sewer, basements, or confined areas. Avoid generation of product as dust. Product should not be released to the environment. Contain and recover waste when possible.

Methods for Cleanup: Sweep or collect spill with an inert material (e.g. vermiculite, dry sand, earth, cloth, or fleece) and place in a non-combustible container for reclamation or disposal. Do not flush to sewer. Clean contaminated surface thoroughly. Residues from spills can be diluted with water. Never return spills in original containers for reuse. 7. HANDLING AND STORAGE

Handling: Wear personal protective equipment (see Section 8). Provide sufficient air exchange and/or exhaust in work rooms. Avoid contact with skin, eyes, and clothing. Avoid generation of dust.
