### 4. FIRST AID MEASURES

#### First Aid Procedures:

- Inhalation:** Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. WARNING! ## 6. ACCIDENTAL RELEASE MEASURES

<b>Personal Precautions and Protective Equipment:</b>	Ventilate area of leak or spill. Isolate hazard area and keep unnecessary and unprotected personnel away from the area of the leak or spill.
