4. FIRST AID MEASURES

First Aid Procedures:

Inhalation: Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial

respiration. WARNING! It may be hazardous to the person providing aid to give mouth-to-mouth resuscitation when the inhaled or ingested material is toxic, infectious, or corrosive. Symptoms and Effects:

Irritation, blistering, burns, visual disturbances, metabolic acidosis, suffocation, shortness of breath, pneumonitis, pulmonary edema, coughing, laryngitis, nausea, vomiting, diarrhea, abdominal pain, blindness, bronchitis, and cardiovascular effects. 6. ACCIDENTAL RELEASE MEASURES
